Refer applicants who require a Planning clearance to the Project Planning Bureau (PPB), Valley Unit - Valley Village Specific Plan staff.


**Note:** Advise applicants that not all projects can be cleared the same day and that an appointment may be necessary.

As per Section 4 of the Specific Plan, please note that the definition of a project is:

**Project:** shall mean the erection or construction of or addition or alteration to any building or structure which increases the height, floor area, number of dwelling units or number of guest rooms on a residentially or commercially zoned property.
